

Commissioners of the County of Hennepin, during the present year, to levy and collect a tax of a sum not exceeding ^{Powers of com} ~~missioners~~ four hundred dollars, on the taxable property of said county, for the purpose of building a bridge across Nine Mile Creek, on the county road leading from the west line of the Military Reservation of Fort Snelling to the west line of the said County of Hennepin.

Sec. 2. It shall be the duty of the Road Supervisors ^{Supervisors to} of the precinct of Bloomington to oversee the erection ^{have charge of} ~~work~~ of said bridge, to keep a correct account of the cost of the same, and make a certified copy thereof to the County Commissioners of the said County of Hennepin, at some stated meeting of the Board, who shall thereupon draw county orders for the amount thereof upon the County Treasurer of said County of Hennepin.

Sec. 3. It shall be the duty of said Road Supervisors of the precinct of Bloomington to build the bridge across ^{Bridge how} ~~the~~ said creek with the least possible expense, and he may at his ^{built} ~~option~~, either issue proposals for the building of said bridge, or cause it to be built by private contract or otherwise, as the case may be.

Sec. 4. This Act shall be in force from and after its passage.

CHAPTER CXXIV.

An Act to locate a State Road from Saint Paul to Chicago City.

- SECTION 1. Appointment of Commissioners to lay out Road.
 2. First meeting of Commissioners.
 3. Expenses to be paid by counties through which road passes.
 4. Commissioners to decide upon the proportion of expenses to be paid by counties.
 5. Plat of road to be recorded.
 6. Power to appoint substitutes.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That Charles N. Mackubin, Washington M.

Commissioners appointed Stees and John M. Lamb, be, and are hereby appointed Commissioners to lay out, mark and survey a State Road commencing at a point where the eastern boundary of the City of Saint Paul cuts the Stillwater road, thence by the most direct and feasible way, via foot of Lake Phalen and intersecting the Anoka and Stillwater road between White Bear and Bald Eagle Lakes to Chisago City, in the county of Chisago.

Meeting of commissioners SEC. 2. The said Commissioners or their substitutes duly authorized, shall meet in the city of Saint Paul on the second Monday in May next, or as soon thereafter as may be practicable, and proceed to survey and lay out said road by the nearest and most feasible route.

Expenses how paid SEC. 3. The expense of laying out and surveying said road shall be paid by the counties through which said road may pass.

Commissioners to decide expenses SEC. 4. The Commissioners shall decide the proportion and amount of such expenses to be paid by said counties through which said road may pass, and notify the Commissioners of each of said counties of the same.

First to be recorded SEC. 5. The above named Commissioners shall cause to be deposited in the offices of the Register of Deeds of the counties through which said road may pass, a copy of the survey of the same.

Power to appoint substitutes SEC. 6. In the event either of said Commissioners shall be unable to perform the duties assigned him in this Act, he shall have power to appoint a substitute, and it shall be his duty to notify the other Commissioners of such substitution: *Provided*, That if at the first meeting mentioned in the Second Section of this bill, either of said Commissioners shall fail to appear in person or by duly authorized substitute, the said appointment shall be declared cancelled, and the Commissioner or Commissioners, or their duly authorized substitute or substitutes there present, shall have the power to select suitable persons to fill such vacancy or vacancies.

SEC. 7. This Act shall take effect on and after its passage.
