

CHAPTER LXXXI.

An Act to authorize the City of Hastings to convey Real Estate for County purposes.

- SECTION 1. Authority to City Council to lease or dedicate public squares to Dakota County.
 2. Act takes effect on passage.

Be it enacted by the Legislature of the State of Minnesota :

Lease or dedication of public square to county

SECTION 1. That the Council of the City of Hastings, in the County of Dakota, in the State aforesaid, shall have power for county purposes, to lease or to dedicate to the said County of Dakota, either one or any portion of one, but not both, nor a portion of both, of the public squares of ground, within the limits of the said city, designated upon the recorded plat thereof, as "Market Square," and "Public Square."

SEC. 2. This Act shall be in force from the date of its passage.

CHAPTER LXXXII.

An Act relating to the Sheriff of Nicollet County.

- SECTION 1. Acts of County Commissioners and Register of Deeds with reference to Sheriff's bond and oath of office, legalized.
 2. Act takes effect on passage.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the acts and doings of the Board of County Commissioners and Register of Deeds of Nicollet

County, in receiving the bonds and oath of office of Lorenzo M. Boardman, the Sheriff elect of said county, at a session of said Board, subsequently to the regular session of County Commissioners in January succeeding such election, and the qualifications of the said Boardman as Sheriff at such subsequent session, be and the same are hereby legalized and confirmed as fully to all intents and purposes as if the said Sheriff elect, had qualified at the regular session in the January preceeding.

CHAPTER LXXXIII.

An Act to amend an Act entitled an Act to Incorporate the Town of La Crescent.

- SECTION 1. Change of Boundary lines in the Town of La Crescent.
2. Act takes effect on passage.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That Section one in the Act incorporating the Town of La Crescent, be amended so as to read as follows, viz : That Section ten (10), north half and the north half of the south half of fractional section eleven (11), east half of the north-east quarter of section nine (9), south half of the south half of section three (3), south half of the south-west fractional quarter of section two (2), and all of Moore and Peterson's addition lying north of the south half of the south
