## CHAPTER LXXXIV.

### *An Act to amend Section 19, of Chapter 18, of the Session Laws of the Extra Session of 1857.*

- SECTION 1. Amends Section 19, defining boundaries of town of Duluth, and naming first President and Town Council.  
2. Act takes effect on passage.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That Section 19 be amended so as to read: That fractional portion of Minnesota Point, lying at the northern extremity of the same, in township forty-eight and township fifty, north of range fourteen west, be and the same is hereby created a town corporate and politic, by the name and style of Duluth, and the corporate name of the town organization shall be the "Town Council of the Town of Duluth." That William Nettleton is hereby appointed the first President, J. B. Culver, Recorder, and R. E. Jefferson, E. H. Rice and William Ord, Trustees; who shall hold their offices until their successors are elected and qualified, and said Town Council may fill or vacate such offices at pleasure.

## CHAPTER LXXXV.

*An Act amending an Act in relation to Free Schools in the town of Minneapolis, "passed May 23, 1857," and relating to the collection of taxes therein.*

- SECTION 1. Amendment to Section 10, relating to the collection of School Taxes.
2. Acts of Trustees of District No. 1, relating to assessing and collecting of tax legalized.
  3. Act takes effect on passage.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. Section ten, (10,) of the act entitled "An Act in relation to Free Schools in the town of Minneapolis," <sup>Collection of</sup> passed May 23, 1857, is hereby amended so as to read as fol- <sup>school tax</sup> lows: All taxes assessed in pursuance of this Act, shall be collected by the Collector of taxes for the town of Minneapolis, upon a warrant issued by the Board of Education and Town Council of said town of Minneapolis, or by civil action, in like manner as other district taxes in the State are, or may be authorized by law to be collected.

SEC. 2. The acts of the late Trustees of School District No. One, in said county of Hennepin, now comprised in the <sup>Acts of trus-</sup> <sup>tees legalized</sup> town of Minneapolis, in reference to the assessment and collection of taxes, are hereby declared in all respects legal and
