CHAPTER LXXXV.

An Act amending an Act in relation to Free Schools in the town of Minneapolis, "passed May 23, 1857," and relating to the collection of taxes therein.

- SECTION 1. Amendment to Section 10, relating to the collection of School Taxes.
2. Acts of Trustees of District No. 1, relating to assessing and collecting of tax legalized.
 3. Act takes effect on passage.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Section ten, (10,) of the act entitled "An Act in relation to Free Schools in the town of Minneapolis," Collection of passed May 23, 1857, is hereby amended so as to read as follows: school tax
All taxes assessed in pursuance of this Act, shall be collected by the Collector of taxes for the town of Minneapolis, upon a warrant issued by the Board of Education and Town Council of said town of Minneapolis, or by civil action, in like manner as other district taxes in the State are, or may be authorized by law to be collected.

SEC. 2. The acts of the late Trustees of School District No. One, in said county of Hennepin, now comprised in the township of Minneapolis, in reference to the assessment and collection of taxes, are hereby declared in all respects legal and Acts of trustees legalized

valid, and any, and all warrants issued by them for the collection of School taxes, upon which any portion of such taxes remain unpaid, and uncollected, shall be returned to the Board of Education of said town, who shall renew the same to the Collector of taxes of said town, who shall thereupon proceed to collect such unpaid taxes in the manner required by law for the collection of School taxes, and return the moneys collected, and his proceedings thereon to said Board of Education.

SECT. 3. This Act shall take effect immediately.

CHAPTER LXXXVI.

An Act to establish Township Organization in the County of Goodhue.

- SECTION 1. Action of voters in certain townships organized into Towns, legalized.
2. Appointment of Commissioners to divide the County into Towns.
3. Notice of elections held for Town Officers to be given to Supervisors within fourteen days.
4. Meeting of Board of Supervisors.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. The action of the legal voters of those townships in the county of Goodhue, that were organized into towns on the 11th day of May, A. D. 1858, in accordance with an Act entitled an Act to provide for Township Organization, approved March 20th, 1858, except without due election notice by the County Commissioners is hereby declared
