## NUMBER VI.

Joint Resolution relative to the Swamp Lands granted to the States by the Act of Sept. 28th, 1850.

Resolved by the Legislature of the State of Minnesota:

That the Governor be requested and authorized to file with the proper authorities, the demand of the State of Minnesota dtempt for the Swamp Lands granted to the States by an Act of Congrant of swamp gress, approved Sept. 28th. 1850, subject to the conditions of lands said grant. And that the notes of the surveys on file in the Surveyor General's office be adopted as the basis upon which such lands will be received.

And it is further Resolved, That all moneys which may be received from the sale of said lands, under or by virtue of, or under the authority of any law for the sale of the same, shall be and remain a fund for the purpose of reclaiming said lands in conformity to the provisions of the said grant.
