 - 4. Repeal of act of 1959.
 - 5. Act take effect on passage.

Be it enacted by the Legislature of the State of Minnesota:

SEC. 2. Members of the Legislature shall not receive pay for more than sixty (60) days of session during any one ray of members year, unless convened in extra session by proclamation of the of Legislature

SEC. 3. The term of office for Senators shall be two (2)

At each succeeding election Senators shall be chosen alternately from districts designated by even and odd numbers, except that there shall be an entire new election of all the Senators at the election next succeeding each new apportionment provided for by the State Constitution.
