An Act to provide for the attachment of Real Estate.

Section 1. Real estate how attached.

- 2. Officer's return prima facie evidence of attachment
- 3. Register to keep record of attachments.
- 4. Fees of Register for receiving and filing copy.
- 5. Repeal of inconsistent acts.
- 6. Act to take effect from and after passage,

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Real Estate, shall be attached on any writ of attachment by the officer leaving a certified copy of such writ, and of his return of such attachment thereon, at the office of neal estate how the Register of Deeds of the county in which such real estate is situated, or if there is no Register of Deeds, with the Clerk of the District Court of the county, and serving a copy of the same upon the defendant in the action if he can be found in his county without any other act or ceremony.

Officer's return evidence of attachment SEC. 2. The officer's return shall always be prima facie evidence that such copy has been so left, and such attachment made, and of the time thereof; but the Register of Deeds shall certify thereon the time when such copy was received and keep the same on file.

Register to keep provide and keep a general index of all attachments made by index of all attachments achments tachments achments the shall enter at the time of receiving the copy of the writ on which the attachment is made, the day of receiving the same,

the Court to which the writ is returnable, and the names of the plaintiff and defendant in the suit, with the names of the defendants alphabetically arranged, which index shall at all

times be open to public inspection.

SEC. 4. The officer making such attachment shall at the time of making the same, pay to the Register of Deeds the Fees for filing atsum of twenty-five (25) cents, which shall be in full for his tachment services in receiving and filing the copy, certifying the time of receiving the same, and entering the attachment upon said index.

SEC. 5. Section one hundred and forty-nine (149) and Subdivision one (1) of Section one hundred and forty-eight (148) Repeal of Public on page five hundred and fifty-one (551) of the Public Stat-Statutes utes of this State, and all acts and parts of acts inconsistent

with this Act are hereby repealed.

SEC. 6. This Act shall take effect and he in force from and after its passage.
