SECTION 1. That so much Territory as is embraced in the following described limits be, and the same is hereby erected District.

into the County of Watonwan; commencing at the northeast corner of town one hundred and seven (107), north of range thirty (30) west, thence west to the north-west corner of town one hundred and seven (107), north of range thirtythree (33) west, thence south to the south-west corner of town one hundred and five (105), north of range thirty three (33) west, thence east to the south-east corner of town one hundred and five (105), north of range thirty (30) west, thence north to the place of beginning. SEC. 2. The Governor shall appoint three suitable per-County Commissioners to be ap- sons who shall constitute a Board of County Commissioners pointed term of for said County, who shall hold their offices until the next general election, or until their successors are elected and qualified; and the said Board of County Commissioners shall have full power and authority to appoint all other County officers in and for said County, and the said Commissioners Powers of County shall have full power and authority to do and perform all acts and duties devolving upon the Board of County Commissioners of any other County in this State.

At the next general election, the electors of the County of Brown County of Brown, the boundaries of which are affected by to vote upon the this act, shall vote for or against the organization of said County of Watonwan; and if a majority of said electors shall vote for such organization, then and thereafter said County of Watonwan shall be established as above described.
