## CHAPTER XIV.

An Act to Legalize the Sale of Lands for Delinquent Taxes in the County of Wassca.

SECTION 1. Sale of lands for taxes in the year 1859, legalized.

9. When to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the sale of lands for taxes by the County Treasurer of Waseca County, in the year eighteen hundred taxes legalized. and fifty-nine is hereby legalized and declared to be as binding as if such lands had been sold at the time prescribed by law.

Sec. 2. This Act shall take effect and be in force from and after its passage.

## CHAPTER XV.

An Act entitled An Act to Legalize the Location and Survey of that Portion of the State Road from the North Shore of Lake Superior to Graham's Point, Commencing at Sauk Rapids and Terminating at Graham's Point on the Red River of the North.

SECTION 1. Location and Survey legalized and Commissioners authorized to file plat.
2. When to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION I. That so much of the location and survey of

rhe location and the State Road from the north shore of Lake Superior to arrey of State Graham's Point on the Red River of the north, commencing to be legal.

A Sauk Rapids and terminating at Graham's Point, be, and

the same is hereby declared to be legal, and the Commissioners of said road are hereby authorized to file the plat of said portion of said road the same as if the entire route had been marked and surveyed as contemplated in an act to provide for the location of said road, approved February twenty-seventh, eighteen hundred and fifty-eight.

## CHAPTER XVI.

An Act to Establish the Town of Delhi in the County of Wright.

SECTION 1. Boundaries defined.
2. Legal votors.
3. When Act takes effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all of township one hundred and twenty-one (121), north of range twenty seven (27) west, and that portion of township one hundred and twenty-one (121), north of range twenty-eight (28) west, all of which is now included in, and known as the town of Clearwater in the County of Wright, be, and the same is hereby set apart from said town of Clearwater, and shall be known as the town of Delhi.

Sec. 2. The citizens, legal voters of said town of Delhi, officers, shall assemble at the house of Israel Darkin in said town,
