## CHAPTER XXXIV.

## An Act to provide for the organization and to define the boundaries of Todd County.

Section I. Boundaries defined.
Jounty Seat
Commissioners appointed; their powers.
Commissioners to post indices of submission of removal of County Seat, and for the election of officers.

## Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the boundaries of Todd County be and Boundaries. the same are hereby established as follows, to wit: Beginning at a point in the Mississippi river opposite the mouth of Platte river, running west to the range line between ranges thirty-five and thirty-six west of fifth principal meridian; thence north on said range line between ranges thirty-five and thirty-six to the corner of towns one hundred and thirtythree and one hundred and thirty-four north to its intersection with the left bank of Crow Wing river, thence along the left bank of Crow Wing river to its junction with the Mississippi, thence down the channel of the Mississippi to the place of beginning.

That the County seat of said County shall be temporarily located at Long Prairie, and there remain until County 8001.

removed in accordance with the provisions of this Act.

That the Governor shall appoint and commission three suitable persons, the same being qualified voters of Governor to apsaid county, with full power and authority to do and perform stoners. all acts and duties devolving upon the Board of County. Commissioners of any organized County of this State, and the said commissioners shall have full power to appoint all officers necessary to the complete organization of said county.

SEC. 4. And it shall be the duty of the said commissioners to post or cause to be posted notices at the several precincts vote on the rein said County at least twenty days before the election holden by Seat. in April next, declaring that the removal of the County-seat of said County to Elk City, in said County, will be submitted to the voters thereof on the day of said election in April, and also that all officers necessary for the organization of Election of consaid county, will, on such day of election be voted for, to- oers. gether with such other matter as it may be necessary for the voters of said County to act upon.

Sec. 5. That if it shall appear that a majority of the votes seat, then it shall be the duty of the County Commissioners to cause a notice of such removal to be published in a weekly paper in this State, for at least four weeks.

Terms of office.

Sec. 6. And the said commissioners and officers so appointed, as provided in section three of this Act, shall hold their terms of office respectively, until their successors are elected and qualified according to law.

Boundaries submitted to a vote.

SEC. 7. That so much of this Act as effects the boundaries of said County, shall be submitted to the citizens of the counties affected thereby, at the next general election, for their approval or rejection; and if a majority voting thereon shall confirm this Act, the boundaries shall be as herein defined.

Sec. 8. That all acts or parts of acts inconsistent with Bepealing clause this act, be, and the same are hereby repealed.

SEC. 9. This act shall take effect from and after its pass-

age.

## CHAPTER XXXV.

An Act amending an act entitled "An Act Incorporating the Town of Chatfield."

SECTION 1. Amends section eleven of Act of Interporation. 2. When to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Section eleven (11) of an act entitled "an Act incorporating the Town of Chatfield" is hereby amended

by adding thereto as follows:
