CHAPTER XLVI.

An Act to legalize certain acts of the President of the Town of Freeborn.

SECTION 1. Legalizes notice of entry of Town of Freeborn. When Act takes effect.

Be it enacted by the Legislature of the State of Minnesota:

SEC. 1. That the notice of the entry of the town of Freeborn, at the United States Land Office at Chatfield, for the Legalizee motice relief and benefit of the rightful claimants thereof, which has been given by the President of said town, be, and is hereby declared to be legal and sufficient.

SEC. 2. This act shall take effect and be in force from and . after its passage.

CHAPTER XLVII.

An Act to establish the County of Ripley.

Smorios 1. Boundaries of Bipley County.
To be ratified. Governor to appoint County efficers.
County Beat.
County to be included in Fourth Judicial District.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That so much of said State as is contained within the following boundaries to wit : Beginning at the Boundaries Boundaries.

north-east corner of township one hundred and eighteen (118) range twenty-nine (29) west of the fifth principal meridian; thence west to the north-west corner of township one hundred and eighteen (118) range thirty-two (32), thence south to the south-west corner of township one hundred and fifteen (115), range thirty-two (32), thence east to the south-cast corner of township one hundred and fifteen (115) range thirty-one (31) thence north to the north west corner of section thirty one (31) of township one hundred and seventeen (117) of range thirty (30), thence east to the north-east corner of section thirty-six (36) of township one hundred and seventeen (117), range twenty-nine (29), thence north to the place of beginning, be and the same is hereby erected into a separate county, and established as the county of Ripley.

Upon the ratification of the several counties to be SEC. 2. affected thereby, the said county is hereby declared to be of organized, and the Governor is hereby empowered to appoint all the county officers required to perform the duties of an organized county, which officers shall duly qualify, and enter upon the performance of their duties, as provided by law, and shall hold their offices until their successors are elected and qualified according to law.

Sec. 3. The county seat of said county shall be and is hereby established at the town of Greenleaf, and the county Commissioners first elected in said county of Ripley, may locate a block in said town of Greenleaf, whereon to erect the county buildings with the consent of the owner or owners thereof.

Judicial District. SEC. 4. Said county shall be included in the Fourth Judicial District.
