CHAPTER LIII.

An Act to amend an act entitled An Act to Incorporate the St. Cloud Bridge Company.

SECTION 1. Extension of Charter. 2. Repeal ng section. 3. When Act takes effect.

SECTION 1. That all privileges granted by an act, Extension of entitled "an Act to incorporate the St. Cloud Bridge Company", Charter. Britension of approved March first, one thousand and eight hundred and fifty-six, are hereby extended and renewed to the said St. Cloud Bridge Company, *Provided*, the said bridge is completed within three years after the passage of this act.

CHAPTER LIV.

An Act to provide for a State Road from Franklin in McLeod County, to Allen's Grove, in Renville County.

SECTION 1. Appoints Commissioners to locate said Road. 2. Meeting of Commissioners. To file Plat. 3. Provides for expenses.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That Peter W. Savage, William Arms and Commissioners appointed. Commissioners appointed. Commissioners to locate and survey a State Road, commencing at the southwest corner of the town of Franklin, in McLeod County, thence to a convenient point on section twenty-eight, town one hundred and fifteen, range twenty-eight, thence to a point eight rods south of the north-west corner of section thirtysix, town one hundred and fifteen, range twenty-nine, thence by the most practicable route by the way of the north-east corner of section three, town one hundred and fourteen, range twenty-nine, to, or near Arm's Grove, and thence to Allen's Grove, in Renville County.
