SECTION 1. Extension of Charter.

SECTION 1. Appoints Commissioners to locate said Road.
 2. Meeting of Commissioners. To file Plat.
 3. Provides for expenses.

Michael Moyer, be, and are hereby appointed Commissioners to locate and survey a State Road, commencing at the south-west corner of the town of Franklin, in McLeod County, thence to a convenient point on section twenty-eight, town one hundred and fifteen, range twenty-eight, thence to a point eight rods south of the north-west corner of section thirty-six, town one hundred and fifteen, range twenty-nine, thence by the most practicable route by the way of the north-east corner of section three, town one hundred and fourteen, range twenty-nine, to, or near Arm's Grove, and thence to Allen's Grove, in Renville County.
