two years and one for three years. At every annual charter election thereafter, there shall be elected in each such ward, one School Inspector, who shall hold his office for three years. No School Inspector shall be entitled to receive any compensation for his services.

SEC. 2. That section six of said act shall be amended and shall read as follows: Section 6. The Board of Education, a majority of the members of which may form a quorum, may meet from time to time, at such place in said city, as Presiding officer, they may designate. The Mayor shall be President of the Board, and shall preside at all the meetings thereof; but in case of his absence, a majority of the Inspectors present, at any meeting, may choose one of their number President pro tempore.
