CHAPTER LIX.

An Act to change the boundaries of the counties of Mille Lac and Benton.

SECTION 1. Part of Benton County detached and attached to Mills Lac County.
2. Subject to a role.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all that part of the county of Benton which lies east of the range line between ranges twenty-Boundaries. seven and twenty-eight be detached from the said county of Benton, and attached to and become a part of the county of Mille Lac.

SEC. 2. This law shall take effect and be in force from and after its adoption by a majority of the electors of each of vote. said counties of Mille Lac and Benton.

CHAPTER LX.

An Act to amend section ten of chapter one hundred and twenty-six of the Session Laws of eighteen hundred and fifty-six.

SECTION 1. Confers certain powers upon Town Council of St. Cloud; also, upon Supervisors of the Township.

Be it enacted by the Legislature of the State of Minnesota:

SEC. 1. Section ten of Chapter one hundred and twentysix of the Session Laws, passed in eighteen hundred and fifty-six is hereby amended so as to read as follows:

SEC. X. The town council shall have power to regulate and improve the levees, streets and alleys, and determine the width of side walks in said town; to regulate the public grounds, to erect a new market house and regulate the markets, to remove all nuisances and obstructions from the streets and commons of said town, and do all things which similar corporations have power to do in order to provide for and secure health, cleanliness and good order in said town.

Powers of Saper. And the Supervisors of the township of Saint Cloud, are hereby authorized to make all needful improvements in any of said streets that are necessary for use as public highways, if said town council shall fail or neglect to make such improvements.

An Act to change the name of Willis Arthur Rogers to Willis Arthur Lont, and to make said Willis A. Rogers the heir at law of O. S. Lont and of Melissa H. Lont, the wife of O. S. Lont, of the Town of Mazeppa.

Section 1. Changes name of Willis Arthur Rogers to Willis Arthur Jont.
2. Constitutes Willis A. Rogers heir at law of C. E. Lout and American A. Lout
3. When Act takes effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the name of Willis Arthur Rogers be and the same is hereby changed to that of Willis Arthur Lout, by which name of Willis Arthur Lout he shall hereafter be known and recognized.
