SEC. 4. Any town or sub-district which has voted a tax according to the provisions of section 25 of said act of March 6, 1862, to pay outstanding indebtedness in-curred as a school district, it shall be the duty of the ser supervisors of said town to levy a tax on the taxable property of such town or sub-district sufficient to pay such indebtedness, and shall issue and deliver to the town treasurer a tax list with their warrant thereto attached, requiring him to collect such tax in the same manner as is herein provided for school district treasurers, and such town treasurer shall receive the same pay for his services, and shall pay out such sums when collected on unredeemed school orders on the said treasurer, and on orders drawn by the supervisors on account of such indebtedness.

This act shall take effect and be in force from SEC. 5. and after its passage.

Approved, March 4, 1863.

## CHAPTER XXXVI.

#### An Act to Provide for the Assessment and Collection of a Special School Tax in District, No. 63, in Goodhus County.

Escricz 1. County Auditor authorized to levy a special school tax. 2. Daty of Gounty Treasurer. 8. When act to take effect.

### Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The County Auditor of Goodhue county is hereby anthorized and directed to assess upon the levy a medal valuation of property for the year 1862, in school district school tax number sixty-three of said county, the sum of two hundred and fifty dollars as a special school district tax.

Duty of County Treasurer

SEC. 2. The County Treasurer of said county is hereby authorized to collect said tax, and pay over the amount collected in the manner as is by law provided for the collection of any taxes assessed in said county. SEC. 3. This act shall take effect immediately.

Approved, March 6, 1868.

## CHAPTER XXXVII.

An Act to Authorize the County Auditor of Ramsey County to apportion Money in School District No. 12, in McLean Township in the County of Ramsey.

SECTION 1. Duty of Board of County Commissioners-duty of County Auditor. 2. When set to take effect.

# Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the County Commissioners of Ram-Duty of Board of sey county are hereby authorized to employ some com-County Commiss petent person to take an enumeration of all persons between the ages of five and twenty-one years, in school sioners-duty of **County Auditor** district number twelve, in McLean township, Ramsey county, and that upon the filing of said enumeration of persons with the County Auditor of Ramsey county, it shall be the duty of said County Auditor when apportioning money to school districts under the provisions of section number twenty-four of "an act to provide for a general system of common schools, the officers thereof, and their respective duties and powers," approved March 6th, 1862, to apportion to said school district number twelve, in McLean township, in accordance with said section number twenty-four aforesaid, any money which said district would have been entitled to by any apportionment of school money for the year 1862, including that of the last Wednesday of March, 1863, had it complied
