would, if he were their issue born in lawful wedlock, and shall be entitled to all the rights and privileges, and subject to all the duties and obligations to which they would be entitled and subject were said foundling their lawful issue; and that said foundling is hereby made the heirat-law of said James A. and Elizabeth A. Dodge, his wife, and shall be entitled to all the other rights and privileges, and subject to all the duties and obligations to which he would be entitled and subject if the said James A. Dodge and Elizabeth A. Dodge, his wife, were his lawful parents.

SEC. 2. That the name of said foundling is hereby declared to be James Emanuel Dodge, and by said name he shall hereafter be known and recognized.

Sec. 3. This act shall take effect from and after its

passage.

CHAPTER LXV.

An Act to vest in William and Mary J. Ray, Parental Power and Control over the person of William George Ray, and to declare the name of said William George Ray.

SECTION 1. Declared the lawful heir of William and Mary Josephine Ray.

3. When act to take effect,

Be it enacted by the Legislature of the State of Minnesota:

Lawful heir of William and Mary J. Ray SECTION 1. That William Ray and Mary Josephine Ray, his wife, of Traverse, in the county of Nicollet, and State of Minnesota, are hereby invested with the same right to, and power and control over the body of William George Ray, an infant child of

the age of five years, that they and each of them would enjoy and possess if the said child was their lawful offspring and issue of their bodies in lawful wedlock, and the natural parents of said child are hereby divested of all right to, and power and control over the body of said child, in any manner or for any purpose whatever.

SEC. 2. The name of said infant child is hereby declared to be William George Ray, and said William Name of child George Ray is hereby declared to be, for all purposes cognizable to the law, the son of the said William and Mary Josephine Ray, and as such son shall be entitled to all the privileges and advantages, and subject to all the duties and liabilities arising from the relation of parent and child.

SEC. 3. This act shall take effect and be in force from and after the date of its passage.
