## CHAPTER IV.

An Act to amend an act entitled an act to provide for a general system of Common Schools, the officers thereof and their respective duties and powers.

SECTION 1. Amendment to Section S3. Teacher to procure register from District Clerk-to keep daily record of attendance and other matters as may be required.

## Beitenacted by the Legislature of the State of Minnesota:

SECTION 1. That section 33 of an act entitled an act to provide for a general system of common schools. the officers thereof, and their respective powers and duties, approved March 6th, 1862, be and is hereby so amended as to read as follows :

Section 33. That the board of trustees may expel any scholar from school for insubordination, immorality or infectious But if any child of suitable age shall be dedisease. nied admission, or any scholar expelled without sufficient cause, or on account of color, social position, or nationality, the teacher so offending, or the board of trustees by whose direction the offence was committed,

**Penalty** for violation of provisions of this act

shall forfeit and pay a fine of fifty dollars for each offence, which may be recovered by suit before any justice of the peace in the county, or court having competent jurisdiction thereof, which suit may be brought by any legal voter of the town, said fine to be applied to the use of the district.

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER V.

An Act supplementary to an act entitled an act in relation to the Redemption of Land sold for Taxes, and relating to Taxes and Tax Sales.

SECTION 1. Conveyances of forficited lands before redemption---County Auditor to deliver to purchaser certificate of sale-what to contain.

- 2. Duty of County Auditor making such sale.
- 5. Kights of persons claiming any title or interest to said premiacs.
- 4. Kights of persons claiming any interest adverse to the claim of the purchaser.
- 5. In case title of purchaser shall be adjudged invalid, said purchaser may retain lien of the state upon mid premises.

SECTION 1. At any time before any tract or parcel of land forfeited to the State under the provisions of chapter four of the general laws of 1862, being an act in relation to the redemption of lands sold for taxes, and relating to taxes and tax sales, approved March
