## CHAPTER LIV.

### *An Act to locate a State road from Stillwater, in Washington County, to Brunswick, in Kanabec County.*

- SECTION 1. Commissioners appointed—for what purpose.
2. When to meet.
  3. When Commissioners to appoint substitutes.
  4. Expenses, how paid.
  5. Compensation of Commissioners and assistants.
  6. To file plat of road.
  7. When act to take effect.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That Robert Rich, Benjamin J. Masterman and George Walker be and are hereby appointed commissioners to locate, mark, survey and establish a State road from Stillwater, in Washington county, by way of Grant, Rice Creek, Brown's Lake, Wyoming and Cambridge, to Brunswick, in Kanabec county.

SEC. 2. The said commissioners, or a majority of them, shall meet in the city of Stillwater, on the last Monday in March next, and then proceed to locate and survey said road.

SEC. 3. In case a majority of the above-named commissioners should fail to convene on the day as provided in section two of this act, it shall be the duty

of the commissioners that may be in attendance on the day so specified, to appoint substitutes.

Expenses, how

SEC. 4. The expenses incurred in the establishing and surveying of said road, shall be paid by the several counties through which the road may pass.

Compensation

SEC. 5. The said commissioners, two chainmen and one axeman shall receive each one dollar and fifty cents per day, and the surveyor three dollars per day, for the number of days employed by them under the provisions of this act.

To file plat of road

SEC. 6. The map or plat, or survey of said road shall be filed by said commissioners in the offices of the several registers of deeds of the counties through which the road may pass, on or before the first day of November, in the year one thousand eight hundred and sixty-four.

SEC. 7. This act shall take effect from and after its passage.
