SECTION 1. That the following sums of money or so much thereof as may be necessary, be and the same are hereby appropriated out of any moneys in the treasury belonging to the general revenue fund, and not otherwise appropriated, for the support of the State Government, for the year eighteen hundred and sixty-five :

1st. For the salary of the Adjutant General, twelve hundred dollars.

2d. For the salary of the State Librarian, four hundred dollars.

3d. For the salary of the Governor's Private Secretary, six hundred dollars.

4th. For the salary of the Commissioner of the State Land Office, three hundred dollars.

5th. For the salary of the Janitor of the Capitol, six hundred and twenty-five dollars.

6th. For clerk hire in the office of the Secretary of State, eight hundred dollars.

7th. For clerk hire in the office of the Auditor of State, eight hundred dollars.

8th. For clerk hire in the State Land Office, eight hundred dollars.

9th. For clerk hire in the office of Treasurer of State, eight hundred dollars.

30th. For printing, binding and advertising for the several State offices, five thousand dollars.

31st. For the publication of all the general laws of this session, in the official paper of the State, not to exceed one hundred dollars.

32d. For reports of the State officers and executive documents for the seventh regular session of the Legislature, three thousand dollars.

33d. For military contingent fund for expenditures properly incurred hereafter for paying, subsisting, clothing, transportation, arming and equipping State troops, called out by proclamation of the Governor, for suppression of Indian hostilities, two thousand dollars.

34th. For the salary of the State Prison guards, two thousand and fifty dollars.

35th. For the salary of the Warden of the State Prison, one thousand dollars.

36th. For the salary of the Deputy Warden of the State Prison, six hundred and twenty-five dollars.

37th. For the salary of the Inspectors of the State Prison, one hundred dollars.

38th. For the salary of the Chaplain of the State Prison, one hundred dollars.

52d. For the payment of interest and exchange on New York, on the eight per cent. loan of two hundred and fifty thousand dollars, and the seven per cent. war loan of one hundred thousand dollars for the year A. D. eighteen hundred and sixty-five, twenty-seven thousand one hundred dollars.

53d. For building Powder Magazine, one thousand dollars.

54th. For the relief of widows and children of citizens of this State, massacred during the Sioux war, the sum of six hundred and ten dollars and twenty-

nine cents, to be paid out of the refugee fund, in accordance with the provisions of chapter fifty-three and fifty-four of session laws of eighteen hundred and sixty-three.

55th. For expenses for revising the statutes, the sum of three thousand five hundred dollars.

56th. For making and furnishing to the State Printer an index of the Journal of the House of Representatives, Journal of the Senate, and the laws of the present session of this Legislature, one hundred dollars each.

SEC. 2. This act shall take effect and be in force from and after its passage.
