## CHAPTER LVIII.

*An Act to provide for the laying out of a State road from Henderson to the State line near the head of Lake Traverse.*

March 8, 1868.

- SECTION 1. Commissioners appointed—for what purpose—expenses—how paid.
2. To file plat of said road.
  3. When and where to meet—may appoint substitutes.
  4. When act to take effect.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That Joseph R. Brown, Mark W. Downie and Theodore Recher are hereby appointed commissioners to locate and mark out a State road from Henderson, in the county of Sibley, on the most direct and feasible route to the State line, near the head of lake Traverse, the expense of laying out the same to be paid by the counties through which said road may pass, the commissioners to decide the amount each county shall pay of such expenses, and notify the county commissioners of such counties of the same: *Provided, however,* that the counties of Sibley, Nicollet and Brown shall not pay any expenses appertaining to the laying out of said road unless the county commissioners of said county shall first agree in writing with the road commissioners so to do, before the laying out of such road; *And provided further,* That no expenses shall be paid for the laying out of said road, over any

now existing road in said counties of Sibley, Nicollet and Brown.

SEC. 2. It is hereby made the duty of said commissioners to make out and deposit a map of said road with the register of deeds of each of the counties through which said road is located.

To file plat of road

SEC. 3. Said commissioners shall meet at Henderson on or before the first Monday in May next, or as soon thereafter as practicable, and proceed to lay out and mark said road. In case either of the commissioners shall be unable to perform the duties assigned him, he shall have power to appoint a substitute, and it shall be his duty to notify the other commissioners of the substitution: *Provided*, That if at the first meeting above named, either of the commissioners shall fail to appear in person or by substitute, then his appointment shall be declared vacant, and the commissioner or commissioners then present shall have full power to select a suitable person or persons to fill such vacancy or vacancies.

When and where to meet—may appoint substitutes.

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER LIX.

*An Act to authorize the counties of Ramsey and Hennepin, or any one of them, to build and maintain a free bridge across the Mississippi river.*

March 3, 1865.

- SECTION 1. Commissioners of the respective counties authorized to issue bonds—for what purpose—at what rate of interest—in what amount.
2. Until bonds paid to remain legal demand against the respective counties—question to be submitted to the voters of the respective counties.
  3. Duties of the commissioners.
  4. If either of said counties decline to co-operate how to proceed.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the commissioners of the counties
