

or other cause disqualifying him from performing the duties of his office, his office shall be declared vacant and another assessor elected by the council to act in his place; his compensation shall be fixed by the council and paid like the salaries of other officers.

When office to be declared vacant—compensation.

SEC. 3. The books, abstracts, maps, blanks and other papers required by law to be delivered by county auditors to assessors, shall be delivered to such assessor by the twentieth day of March, eighteen hundred and sixty-five, and annually thereafter, by the fifteenth day of January, and he shall immediately thereafter, enter upon the duties of his office. The election of assessor after this year shall take place at the first regular meeting of the city council in January.

When books and papers to be delivered—regular election.

SEC. 4. The said assessor shall have till the first day of September to complete his assessment.

When assessment to be completed.

SEC. 5. This act shall take effect from and after its passage.

CHAPTER LXXX.

An Act to provide for the advertisement and sale of the lands in Fillmore county forfeited to the State for non-payment of taxes.

March 2, 1865.

SECTION 1. Sale of forfeited lands for non-payment of taxes—how.
2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That the lands forfeited to the State in Fillmore county, for the non-payment of taxes under the several laws upon that subject, and which were or-

dered by the Auditor of State to be advertised and sold on the ninth day of January, eighteen hundred and sixty-five, shall be advertised by the county auditor of Fillmore county, in the manner and the number of times provided by law, and shall be sold as provided by law, on the first Monday in May, eighteen hundred and sixty-five.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER LXXXI.

March 2, 1865.

An Act to authorize the Clerk of the District Court, Sixth Judicial District, in and for the county of Nicollet to transcribe the records of his office.

SECTION 1. Clerk of District Court authorized to procure books to transcribe records of his office.

2. Duty of county commissioners—fees of clerk.
3. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota :

Authorized to pro-

SECTION 1. The clerk of the district court of the sixth judicial district, in and for the county of Nicollet, is hereby authorized and required to procure, so far as may be necessary, such book or books as may be required to carry out the provisions of this act, at the expense of the said county of Nicollet; and to transcribe under the supervision and direction of the judge of said district into such book or books, all judgments and entries of any judgements, and all the records of said court, to the extent that the said district judge may deem necessary; and the said judgment or judgments
