

be punished by fine not less than twice the value of the property so sold or disposed of, or confined in the county jail not exceeding one year, or both, at the discretion of the court, and until the fine and all costs of such prosecution are paid.

SEC. 2. This act to take effect and be in force from and after its passage.

CHAPTER XXXI.

An Act to Prohibit Persons or Companies from taking ice from the Mississippi, St. Croix and Minnesota Rivers, without Erecting suitable safe-guards around the place from which the ice is taken. March 2, 1866.

SECTION 1. Prohibits persons taking ice from Mississippi, St. Croix and Minnesota rivers without suitable safeguards.

2. Penalty for violation of provisions of this act.
3. When Act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Any person or company who may be engaged in taking ice from the Mississippi, Minnesota and St. Croix Rivers, is hereby required to erect a fence or hand railing, at least three and one half feet high, with at least two boards, around the place from which the ice is taken, and maintain the same there until the ice is sufficiently strong to bear a person or beast, and any person or company neglecting to comply with this act, shall be liable to the penalties hereafter provided. Persons taking out ice to erect fence.

SEC. 2. Any person or company who shall violate any of the provisions of this Act, shall be subject to

Persons aggrieved may sue.

a fine of not less than twenty-five dollars or more than fifty dollars and be liable to pay all damages that any person or persons may sustain by violation of the provisions of this act, and the parties who shall sustain any damages by a violation of this act, may sue for and collect the same in any court in this State.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER XXXII.

March 2, 1866.

An Act Punishing the Depositing or Casting of the Dead Bodies of Animals or the offal of such animals in the Mississippi River or Lake Pepin or in any other Lake, Creek or River in the State of Minnesota.

SECTION 1. Punishes by fine or imprisonment any person depositing dead animals or their offal in the Mississippi or any other lake or river in State of Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Penalty for throwing offal, &c. in lakes or river.

SECTION 1. Whoever wilfully or knowingly deposits or casts into the Mississippi river or Lake Pepin or any other lake, creek or river in the State of Minnesota, or deposits upon the ice of either, the dead body of any horse, ox or other animal, or the offal of any such animal, shall be punished by imprisonment in the county jail not more than fifteen days or by fine not exceeding twenty dollars nor less than five dollars.
