

Miscellaneous
appropriations.

17th. To Cutter, Secombe & Averill, for stationery furnished the Senate, one hundred and eighty-two dollars and fifty-five cents.

18th. For furnishing paper necessary for the publication of the State laws and documents, as provided by law, three thousand dollars.

19th. To Robert Kennedy, for subsistence furnished recruits and others in service of the State, one hundred dollars, in full of all demands to date.

20th. To Moses Hollister, clerk in Auditor's office, for recording and keeping records of railroad trust deeds and other conveyances of real estate, two hundred dollars.

21st. For claim of C. F. & W. Powell, ninety dollars and thirty-one cents, for hardware furnished to Northern Rangers.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER LV.

February 25, 1866 *An Act to appropriate money to cover deficiencies therein stated for the year 1865.*

SECTION 1. Appropriation for deficiencies for eighteen hundred and sixty-five.

1. Deficiency of appropriation for incidental expenses of State Prison.
2. Deficiency of appropriation for printing Revised Statutes, Executive Documents and other State Printing.
3. Deficiency of appropriation for Blind and Deaf mutes.
4. Deficiency of appropriation for the support of the Insane.
5. Deficiency of appropriation for repairs of State Capitol.
6. Deficiency of appropriation for taking the census.
7. Deficiency of appropriation for expenses of State Geologist.
8. Deficiency of appropriation on account of expenses incurred in suppressing Indian hostilities.

9. Deficiency of appropriation for clerk hire in Adjutant General's office.
 10. Deficiency of appropriation for rent of powder magazine.
 11. Deficiency of appropriation in the purchasing and adjusting locks for Auditor of State and Treasurer of State.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following sums of money, or [so] much thereof as may be necessary, be and the same are hereby appropriated out of any moneys in the treasury not otherwise appropriated.

1st. For deficiency of appropriation for salaries of guards, for groceries and provisions and other incidental expenses of the State prison for the month of December, eleven hundred and twenty-five dollars and forty-two cents.

2d. For deficiency of appropriation for printing Revised Statutes, Executive Documents and other State printing, eight hundred and fifty dollars.

3d. For Deficiency of appropriation for Blind and Deaf Mutes, five hundred dollars.

4th. For deficiency of appropriation for the support of the Insane, seven hundred and fifty dollars.

5th. For deficiency of appropriation for the repairs of State Capitol, six hundred and twenty-five dollars.

6th. For deficiency of appropriation for taking the census, five hundred dollars.

7th. For deficiency of appropriation for expenses of State Geologist, twelve hundred and seventeen dollars and fifty-four cents.

8th. For deficiency due on account of expenses incurred in suppressing Indian hostilities, nine thousand and ninety three dollars.

9th. For deficiency of appropriation for clerk hire in Adjutant General's office, one hundred dollars.

10th. For deficiency of appropriation for rent of powder magazine, eighty dollars.

11th. For deficiencies due on account of expenses incurred in purchasing and adjusting two of "Covert's patent permutation bank locks" on safes in the office of the Auditor of State and Treasurer of State, two hundred and fifty dollars.

12th. For deficiencies due for preparing Attorney General's opinions for publication, one hundred and fifty dollars.

13th. For deficiency due for packing boxes for Laws of 1865, eighty five dollars.

14th. For deficiency of appropriation for preparing and indexing Laws and Journals of Legislature of 1865, three hundred dollars.

15th. For deficiency due for journal and ledger for State Auditor's office, thirty five dollars.

16th. For deficiency due Board of Examining Surgeons, one hundred and eighty dollars.

17th. For deficiency due for powder used in firing salutes on the return of Minnesota troops to the State, two hundred and eighty-eight dollars.

18th. For deficiency due P. Donovan & Co., on counters and fixtures in the offices of the State Auditor and State Treasurer, sixty-two dollars and fifty-five cents.

Sec. 2. This act shall take effect and be in force from and after its passage.
