The said bonds shall be signed by the di-Bonds to be sign-Sec. 3. rector of said district and shall be attested by the ed. clerk thereof.

SEC. 4. The proceeds of the sale of the bonds pro-vided for by this act shall be applied exclusively by be applied. the trustees of said district in the purchase of a suitable site and the erection thereon of a proper building for the purpose of common schools in said district.

This act shall take effect from and after its passage.

CHAPTER XXXIII.

An Act to legalize the action of the Trusteen of School District No. Fourteen in Faribault county in issuing the bonds of said district to build a school house therein.

SECTION 1. Legalizes the action of Trustees of School District No. Fourteen of Faribault County.

2. When Act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the action of the trustees of school district No. fourteen in Faribault county in issu-tees to be legal. ing bonds to an amount not exceeding the sum voted by the legal voters, to be raised for the purpose of erecting a school house in said district, be and the same is hereby declared legal and binding upon the inhabitants and tax-payers of said district.

Sec 2. This act shall take effect and be in force from and after its passage. Approved February 23, 1866.

An Act to legalize the action of the Board of Trustees of School District No. Thirty-two of the township of Watertown, of the County of Carver, in contracting for the building of a school house in said district, and for other purposes.

Section 1. Legalizes action of Board of Trustees of School District number thirty-two of Watertown, Carver County.

- 2. Roard authorized to issue bonds for certain purposes.

- 5. Board of Trustees may issue bonds under certain restrictions.

Section 1. That the action of the board of trustees Board of Trustees of school district number thirty-two of the township of Watertown, of the county of Carver, in purchasing a site and contracting for the building of a school house thereon, and all other acts of said board of trustees relating thereto, be and the same is hereby legalized and made valid.

May issue bonds.

Sec. 2. The board of trustees of said school district number thirty-two, of Carver county, is hereby authorized to issue bonds for the purpose of payment of said site, and the building and finishing of a school house thereon, in a sum not exceeding three thousand five hundred dollars, to be issued in such denomina-
