SEC. 3. All the field notes and maps of said road shall be filed with the register of deeds of Saint Louis county, and a copy thereof in the State bureau of public lands.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER XCIX.

March 1, 1866. An Act to lay out a State Road from Twin Lakes and Du Luth to Vermilion Falls.

Be it enacted by the Legislature of the State of Minnesota:

Nominates Commissioners.

SECTION 1. That E. F. Ely, Sydney Luce and George E. Wheeler are hereby appointed commissioners to lay out and establish a State road from Twin Lakes, in the county of Carlton, and from Du Luth, in the county of St. Louis, to some convenient point of intersection, and from thence by the nearest [and] most feasible route to the Vermilion Falls, near the head of Lake Vermilion, in the county of St. Louis.

Commissioners to hold mestings.

SEC. 2. The commissioners hereby appointed may meet at any time after the passage of this act and proceed to lay out said road, and after the same is surveyed shall cause a map thereof to be filed in the office of the Secretary of State, and a duplicate thereof

in the office of register of deeds in said county of St.

SEC. 3. The expense of the location and survey of Expenses—how this road shall be paid by the counties of St. Louis and defrayed. Carlton, in proportion to the distance of said road in

each county.

SEC. 4. If any of the commissioners hereby appoint-Yacancies—How ed shall refuse or neglect to act, after being notified of the time appointed for the commencement of the location of the road, then his associated commissioners may appoint some other person to act on said board, and said person so appointed shall perform the duties with all the powers, and shall be entitled to the same pay as if he had been named in this act.

Sec. 5. This act shall take effect and be in force

from and after its passage.
