

CHAPTER OXXIII.

February 21, '07

An Act to locate a state road from Greenleaf, Meeker county, to Lake Lillian, in Kandiyohi county.

- SECTION 1.—Nominates three commissioners.
 2.—Commissioners to meet—when.
 3.—Route of road.
 4.—Commissioners may employ assistants.
 5.—Plat to be filed.
 6.—When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Commissioners,

SECTION 1. That William H. Greenleaf, O. C. Hart and John A. J. Bomsta are hereby appointed commissioners, whose duty it shall be to locate and establish a state road from Greenleaf, in Meeker county, to Lake Lillian in Kandiyohi county, to intersect the state road running from Henderson to Big Stone Lake.

Organization

SEC. 2. Said commissioners shall, on some day subsequent to the passage of this act, and prior to the first day of September next, meet at the village of Greenleaf and proceed to perform the duties imposed by this act.

Route of road

SEC. 3. Said road shall commence at a point on Main street, in the village of Greenleaf, where said street intersects the west line of range thirty, and shall follow the most direct and feasible route to Lake Lillian and to a point where said road intersects the state road from Henderson to Big Stone Lake.

Assistants

SEC. 4. Said commissioners are hereby empowered to employ one axman, one chainman and one surveyor. Said axman and chainman shall receive not exceeding two dollars and said surveyor three dollars per day for their services in locating said road. The commissioners appointed by this act shall receive for their services under the provisions of this act, a sum not exceeding two dollars per day, and the expenses incurred in the location of said road shall be borne by the counties through which said road shall pass.

SEC. 5. The said commissioners shall, on or before the first day of November next, file with the auditors of the respective counties through which said road shall pass, maps and field notes of the survey of said road, and on the filing of the maps and field notes as aforesaid, the said road shall be deemed to be located and established.

Plat to be filed

SEC. 6. This act shall take effect and be in force from and after its passage.

CHAPTER CXXIV.

An Act to legalize and confirm the proceedings of the commissioners appointed to locate a state road from Hokah to Riceford, by way of Sheldon, in Houston county, and to establish said road.

March 1, 1867

SECTION 1.—Legalizes proceedings of commissioners.

2.—When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The acts and doings of the commissioners appointed under an act entitled "an act to locate a state road from Hokah to Riceford, by way of Sheldon, in Houston county, approved March 4, 1864," in locating the state road described in the above entitled act be and the same are hereby legalized, confirmed and made valid, and said road is hereby declared to be a state road; *Provided, however,* That nothing in this act shall be construed to exempt any of the towns through which said road passes from paying its proportion of the expense of laying out and locating said road as is provided in section 7 of said act.
