## CHAPTER CL.

An Act to change the names of divers persons, &c.

March 8, 8 1867

SECTION 1-Changes name of various parties. 2--When act to take effect.

## $\dot{\,\,\,\,\,\,}$ Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The name of Mary Dunn is hereby changed to Mary Haley, and she is hereby constituted the heir at law of William Haley and Catherine Haley his wife, of the county of Nicollet and state of Minnesota.

The name of Peter Mathias is hereby changed to Peter Reck, and he is hereby constituted the heir at law of Charles Reck and Madeline Reck, of the county of Wabasha and state of Minnesota.

The name of Peter Stiern is hereby changed to Peter Stiern, and he is hereby constituted the heir at law of Peter Stiern and Catherine Stiem, of the county of

Scott, and state of Minnesota.

The name of Elay Burch is hereby changed to Nellie Currier, and she is hereby constituted the heir-atlaw of R. W. Currier, of Hennepin county, Minnesota.

The name of Louisa Cowles is hereby changed to Louisa C. Williams, and she is hereby constituted the heir at law of Charles D. Williams and Eveline B. Williams.

The name of Charles Howard Daw is hereby changed to Charles Howard Dorothy, and he is hereby constituted the heir at law of Michael Dorothy and Mary Change of names Dorothy.

Williams.

That the name of Swen Nelson, of Minnesota, residing on section 15, township 34, range 20, in the county of Chisago, is hereby changed to Swen N. McLean.

That the name of Johanna Westergreen, of Taylor's Falls, Minnesota, is hereby changed to Johanna Josephine Holm, and she is hereby declared to be the

daughter and heir at law of Andrew Holm.

That the name of Nathan Sargent Dustin, of Hastings, Minnesota, is hereby changed to that of Nathan Sargent, Junior, and he is hereby constituted heir at

law of Nathan Sargent.

That the name of Francilla Farlen, a minor child, be and the same is hereby changed to Fannie Maria Chase, and she is hereby declared to be the daughter and heir at law of Leonard P. Chase and Mary W. Chase, of Minneapolis, Minnesota, to all intents with all the rights of inheritance as though born their natural heir.

That the names of Emma Josephine Barrett and John Wesley Barrett are hereby changed to Emma Josephine Change of Dame Smith and John Wesley Smith, respectively, and they are hereby declared to be the adopted children and heirs at law of Andrew J. Smith and Lorinda Smith, in all respects in law and equity.

That the name of Harriet E. B. McConkey, of St. Paul. Ramsey county is hereby changed to Harriet E. Bìshop.

That the name of Peter Johnson, of the town of Taylor's Falls, Chisago county, is hereby changed to the name of Peter Farnel.

SEC. 2. This act shall take effect and be in force from and after its passage.

An Act to bestow a name and heirship upon the adopted February 21 '67 daughter of Rollin B. Gibson and Elizabeth M. Gibson.

SECTION 1-Confers name on adopted daughter.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of Mary Agnes Gibson Confers name be, and the same is given to the adopted daughter of Rollin B. Gibson and Elizabeth M. Gibson, of the town of Guthrie, county of Faribault, Minnesota.
