An Act to authorize the county commissioners of the county of Isanti to issue bonds.

SECTION 1.—County Commissioners authorized to issue bands for bridge purposes-

Be it enacted by the Legislature of the State of Minnesota:

May issue bonds

Section 1. That the county commissioners of the county of Isanti be, and the same are hereby authorized to issue bonds to an amount not exceeding two thousand five hundred dollars for the purpose of raising money to build two bridges across the Rum river in said county-one at Cambridge and the other at Spencer brook.

SEC. 2. Said bonds shall be of such denomination Denomination of as shall be determined by the board of county commissioners of said county, and shall be made payable to the bearer, and shall be signed by the chairman of said board, and attested by the county auditor, and the official seal of said county attached, and shall bear interest at a rate not exceeding ten per cent. per annum, payable semi annually in the city of St. Paul, and shall be made payable at any time not less than six years nor more than twelve years from the date thereof.

Sec. 3. It shall be the duty of the chairman of the board of county commissioners and the county auditor to execute such bonds, at such times, in such amounts, and to such persons as the said board may direct, in conformity with the provisions of this act; and the said bonds so issued and executed shall be a valid and binding debt against the said county of Isanti.

SEC. 4. The board of commissioners of said county way tery tax are hereby authorized and empowered to levy an annual tax upon all the taxable property of said county, in addition to the taxes provided by law to be levied, sufficient to pay the interest on said bonds so issued, and also to levy an additional tax to pay the principal of said bonds as they shall become due, which taxes shall be levied and collected in the same manner as other county taxes are levied and collected.

SEC. 5. The said board of county commissioners, or How resolved a majority of them, shall have authority to negotiate said bonds as in their judgment shall be best for the interest of said county and the speedy erection of said

bridges.

Sec. 6. This act shall take effect and be in force from and after its passage.
