Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the following sums of money, or so much thereof as may be necessary, be and the same are for support the hereby appropriated out of any moneys in the treasury State governm't belonging to the general revenue fund, for the payment of the salaries of the state officers, and for the support of the state government for the year one thousand eight hundred and sixty-seven:
