Be it enacted by the Legislature of the State of Minnesota:

Section 1. There shall be but one general term of the district court in the first judicial district, in the county of Chisago, to wit:

On the first Tuesday in May.

CHAPTER CIII.

An Act to fix the time for holding general terms of the district court in the counties of Wright, Sherburne, Stearns, March 4, 1868. Meeker, Morrison, Douglas, St. Louis, Benton and Mille Lac.

SECTION 1. Time of holding terms of District Court.

- 3. All processes to be returnable to said terms of Court.
- 4. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The general terms of the district court shall 19

be held in the following named counties, at the time hereinafter specified, namely:

In the county of Wright, annually, on the first Tuesday

in June.

In the county of Sherburne, annually, on the second Tuesday in June.

In the county of Stearns, annually, on the third Tues-

Time of holding day of June, and second Tuesday in December. In the county of Meeker, annually, on the fourth Tues-Court.

day in September.

In the county of Morrison, annually, on the third Tuesday in October.

In the county of Douglas, annually, on the first Tuesday

in October.

In the county of St. Louis, on the first Tuesday in August, in the year eighteen hundred and sixty-nine (1869), and every two years thereafter, on the first Tuesday in August.

In the county of Benton, annually, on the last Tuesday

in November.

In the county of Mille Lac, on the first Tuesday in August, in the year eighteen hundred and sixty-eight (1868), and every two years thereafter on the first Tuesday in August.

Repeal of former acta.

All acts and parts of acts fixing any other time SEC. 2. for holding general terms of the district court in the counties aforesaid, or either of them, are hereby repealed.

All process or proceedings issued, had or done, for any general term of the district court in any of the aforesaid counties, as heretofore fixed by law, shall be returnable to the next term of said court holden in such county at the time herein specified, and shall be as valid and binding in all respects, as though such terms had not

been changed.

When act to take effect.

Sec. 4. This act shall take effect and be in force from and after its passage.
