An Act to provide for the trial of offenses upon information. March 6, 1868.

- SECTION 1. Courts may have the same powers in cases upon information as in like cases upon indictment.

That the several courts of this state shall possess, and may exercise the same power and jurisdic-incases upon tion to hear, try, and determine prosecutions upon information for crimes, misdemeanors and offenses; to issue writs and process, and do all other acts therein, as they possess and may exercise in cases of like prosecutions upon indictment.

All the laws of this state applying to prosecutions upon indictments, to writs and process therein, and the issuing and service thereof, to motions, pleadings, trials and punishments, or the execution of any sentence, and to all other proceedings in cases of indictment, whether in the court of original or appellate jurisdiction, shall in the same manner, and to the same extent, as near as may be, apply to informations, and all prosecutions and proceedings thereon.

Any person who may according to law, be committed to jail, or become recognized or held to bail May be commit with sureties for his appearance in court to answer to any indictment, may in like manner, so be committed to jail, or become recognized and held to bail for his appearance, to answer to any information or indictment, as the case

may be.

CHAPTER LXXXVIII.

An Act to prescribe the penalty for the crime of murder in the first degree.
