

CHAPTER XCIX.

February 29, 1868

An Act to amend section thirty (30), of chapter sixty-four (64), of the General Statutes of the State of Minnesota, relating to the general terms of the district court.

SECTION 1. Amendment to Section 30, Chapter 64, General Statutes. Time of holding terms of District Court in Sixth Judicial District.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section thirty (30), of chapter sixty-four (64), of the general statutes of this state, be amended so as to read as follows:

Time of holding
Court, Sixth Ju-
dicial District.

Sec. 30. In the sixth (6th) judicial district, in the county of Brown, on the third (3d) Tuesday of June.

In the county of Blue Earth, on the third (3d) Tuesday of May, and the first (1st) Tuesday of December.

In the county of Faribault, on the first (1st) Tuesday of June.

In the county of Martin, on the third (3d) Tuesday of October.

In the county of Nicollet, on the first (1st) Tuesday of May, and the third Tuesday of November.

In the county of Sibley, on the third (3d) Tuesday of March, and the first (1st) Tuesday of October.

In the county of Le Sueur, on the first (1st) Tuesday of March, and the third (3d) Tuesday of September.

In the county of Renville, on the first (1st) Tuesday of April, eighteen hundred and sixty-eight (1868), and on the first (1st) Tuesday of September in each year thereafter.

The county of Watonwan is hereby re-attached to the county of Blue Earth for judicial purposes; and chapter one hundred and eleven (111), of the general laws of eighteen hundred and sixty-seven (1867), is hereby repealed. And all actions and proceedings now pending in

said county of Watonwan shall be transferred to, and tried in said county of Blue Earth, as they would have been if said chapter one hundred and [eleven] (111) had never been passed.

SEC. 2. This act shall take effect and be in force from and after its passage. When act to take effect.

CHAPTER C.

An Act to amend section twenty-five (25), title three (3), of chapter sixty-four (64), of the General Statutes, relating to the terms of the district court for Goodhue county. March 4, 1868.

SECTION 1. Amendment to Section 25, Chapter 64, General Statutes. Time of holding terms of District Court in Goodhue County.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the first (1st) subdivision of section twenty-five (25), title three (3), chapter sixty-four (64), of the general statutes, be so amended as to read as follows:

The general terms of the district court shall be held in each year, at the time and places following:

In the first (1st) judicial district, in the county of Goodhue, on the second (2d) Tuesday in December, and the third (3d) Tuesday in May.

SEC. 2. This act shall take effect and be in force from and after its passage. Time of holding District Court in Goodhue county
When act to take effect.
