of any other railway to be constructed into or through said county, and the total amount of bonds so proposed to be issued shall be included in a single proposition, and the form of the tickets to be used by those voting for and against said joint proposition shall be prescribed by the commissioners of said county, and public notice thereof given at least fifteen days previous to such election. Provided however. That not less than one half of the amount so appropriated shall be by said commissioners applied in the construction of the Owatonna and State Line Railway aforesaid. provided further, That the total amount of bonds to be issued in any and all cases under the provisions of this actshall never exceed the sum of one hundred thousand dollars, and that no portion thereof shall ever be applied or expended for the construction of any portion of said railways, outside of the limits of said county of Freeborn.

When act to take effect.

Sec. 7. This act shall be in force and take effect from and after its passage.

CHAPTER CIX.

Februa'y 14,1868

An Act to authorize the Register of Deeds of Goodhue county to transcribe and record town plats.

SECTION 1. Register of Deeds authorized to transcribe all town plats—for what purpose...

- 8. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Register to transcribe all town plats—for what purpose.

Section 1. That the register of deeds of the county of Goodhue, in the state of Minnesota, be and he hereby is authorized to transcribe all town plats which now are or hereafter may be on file in his office, and by law requir-

ed to be recorded into a book suitable for that purpose. and for the permanent preservation of the same, which said book may be provided by the county commissioners

of that county at the expense of the county.

SEC. 2. That the transcribing of all plats as provided To have same by section one (1) of this act, shall have the same force force as though and effect as though the same had been originally recorded corded. in such books, in pursuance of the provisions of chapter twenty-nine (29), of the general statutes of the State of Minnesota.

CHAPTER CX.

An Act to authorize the County Commissioners of the county of Pope to issue bonds.

- Section 1. County Commissioners authorized to issue bonds—in what amount—for

 - 4. Bonds so issued to be signed by the Chairman of the Board of County Commissioners and countersigned by the County Auditor.
 - By whom bonds to be negotiated.

Be it enacted by the Legislature of the State of Minnesota:
