commissioners of the county of Sherburne, in the state of Proceedings of Minnesota, for the purpose and with the intention of legalized. redistricting such county, in the month of June of the year eighteen hundred and sixty-six, and all official acts and proceedings affected by such redistricting, be and the same hereby are legalized and made valid to all intents and purposes, and shall and do have the same force and effect as though such proceedings had been in strict conformity to the provisions of the law, made and provided for the redistricting of counties into districts, equal to the number of members constituting the board of commissioners of such counties respectively, and that all elections of county officers of said county of Sherburne, since such proceedings and before the passage of this act, be and the same hereby are in all respects legalized and made valid.

Sec. 2. This act shall take effect and be in force from When act to take and after its passage.

CHAPTER CXIII.

An Act to locate the county seat of Chippewa county.

March 6, 1868.

SECTION 1. Temporary location of county seat.

When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. The county seat of Chippewa county is Temporary lohereby temporarily located at Chippewa city, in said catton of county county.

SEC. 2. This act shall take effect and be in force from When act to effect. change the boundary line of Renville county," passed by

the legislature of the state of Minnesota, in the year one thousand eight hundred and sixty eight.

CHAPTER CXIV.

An Act to change the status of the Agricultural College of Minnesota.

SECTION 1. Transfer of the Agricultural College.

- 2. Transfer of all lands donated as an Agricultural Farm—duty of Governor.
- 8. All the swamp lands in McLeod County set apart for said College, are transferred and vested in the Board of County Commissioners of said county -duty of Governor.
- 4. Repeal of former sections.
- When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Transfer of the Agricultural College.

Section 1. That the institution known as the agricultural college of Minnesota, established by acts of the legislature of Minnesota, on certain lands in township one hundred and fifteen, range twenty-eight, is hereby transferred to and vested in the "Stevens' Seminary" incorporated February twentieth, one thousand eight hundred and sixty-eight. Provided, Said Stevens' Seminary shall be located in the same township, on such lands as the trustees thereof shall select for that purpose.

SEC. 2. That all the lands in said township that have been donated and deeded to the state of Minnesota for the Transfer of all purpose of an agricultural college or agricultural college farm, and which now appertain to or belong to said college or to the state of Minnesota for the uses and purposes of the college, are hereby transferred and donated to and vested in said Stevens' Seminary, and the governor is hereby authorized to execute the necessary deed or cer-

lands donatedduty of Governor.
