# CHAPTER XXV.

An Act to amend an act to authorize the Town of Chatfield to issue bonds to aid in the construction of a Railroad to Chatfield.

March 5, 1868.

SECTION 1. Authorized to issue bonds in the sum of twenty-five thousand dollars to aid in the construction of a railroad to said town.

- 2. Extension of time.
- 3. Authorizing any town to issue bonds to aid in the construction of said road -to levy a tax for the same-amount of bonds not to exceed twenty-five thousand dollars.
- 4. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section one (1), of an act entitled "an act to authorize the town of Chatfield to issue bonds to aid in the construction of a railroad to Chatfield, approved February twenty-fourth (24), eighteen hundred and sixty-six (1866), be and the same is hereby amended so as to read as follows:

Sec. 1. The town of Chatfield, county of Fillmore is hereby authorized to issue prior to January first (1st), Authorized to eighteen hundred and seventy-five (1875), bonds to an what amountamount not exceeding in the whole, the sum of twenty-five what for. thousand dollars, to aid in the construction of a railroad to Chatfield aforesaid.

SEC. 2. And be it further enacted, that section four (4), of said act, approved February twenty-fourth (24th), eighteen hundred and sixty-six (1866), is hereby amended so that the following words, viz., prior to said first day of January, eighteen hundred and sixty-eight (1868), shall read prior to said first (1st), day of January, eighteen hundred and seventy-five (1875).

SEC. 3. Amend section five of said act so as to read, Towns may is-"Any other town may at any annual or special meeting sue bonds levy within the time aforesaid authorize the issue of bonds in to exceed \$25,000

aid of the construction of said road and provide for the levy of a tax to pay the same, in the same manner and upon the same terms and conditions as are hereinbefore provided in respect to the bonds which said town of Chatfield is hereinbefore authorized to issue. *Provided*, That the whole amount of bonds issued by any one town under this act shall not exceed the sum of twenty-five thousand dollars."

SEC. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER XXVI.

An Act to reduce the Law incorporating the City of Saint Paul, in the County of Ramsey, and State of Minnesota, and the several Acts amendatory thereof, into one Act, and to amend the same.

### CHAPTER I.

### BOUNDARIES OF CITY AND WARDS.

SECTION 1. The several acts incorporating the City of St. Paul consolidated and incorporated into one act.

- 2. Corporate rights of said City.
- 3. Boundary lines of the City of St. Paul.
- 4. Divided into five Wards-names of Wards-boundary lines of each Ward.
- Common Council may change the boundaries of the several Wards, or inorease the number.

#### CHAPTER II.

#### ELECTIONS.

- SECTION 1. When annual election to be held—length of time the polls to be kept open notice to be given.
  - 2. Elective officers of said City-term of office of City Assessor and City Comptroller.
  - 3. Persons appointed or elected to any office may be removed for cause-how.
  - 4. Vacancies how filled.
