heretofore issued while it was school district number one of Blue Earth county, to build a school house; said bonds not todraw a higher rate of interest than twelve per cent. per annum, and to run not longer than ten years from the date of their issue; the amount of bonds, the rate of interest, and the times when payable shall be fixed and determined by the voters of said district, at a meeting thereof upon due notice of the object thereof given as required in case of special meetings of the district

How bonds to be issued and paid. SEC. 2. The said-bonds shall in all particulars not inconsistent with this act, be governed by and issued and paid in accordance with the general law of this state, authorizing school districts to issue bonds to build school houses.

When set to take effect.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER LVI.

An Act to organize certain territory herein described, in February 1,1868 the County of Wabasha, into a special school district.

SECTION 1. Boundary lines of said Special School District.

- 2. Repeal of inconsistent acts.
- 3. When act to inke effect,

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section twenty-five (25), and the east half of section twenty-six (26), and the east half of section thirty-five (35), and the whole of section thirty-six (36), in town one hundred and eleven (111) range eleven (11), and the whole of fractional section nineteen (19), and as much of sections thirty (30) and thirty-one (31), town one hundred and eleven (111) range ten (10), as

lays north and west of Phelps street, in the city of Wabasha, is hereby created into a special school district, to be governed by the general laws of schools in and for the state of Minnesota.

Sec. 2. All acts or parts of acts inconsistent with the provisions of this act, are hereby repealed.

SEC. 3. This act shall take effect and be in force from when act to take and after its passage.

## CHAPTER LVII.

An Act to authorize the board of county commissioners of the county of Wabasha to change the boundaries of school district number thirty, and to form a new district.

March 5, 1868.

SECTION 1. Board of County Commissioners authorized to alter the boundary line of School District number thirty.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the board of county commissioners of the county of Wabasha, be and the same are hereby May alter the authorized and empowered at any time before the first boundary of day of September, eighteen hundred and sixty-eight, to number thirty. alter the boundary line of school district number thirty (30), in Wabasha county, or to form a new school district from any part of said school district number thirty (30), and of any territory adjoining said district, upon application in writing signed by five legal voters living within said school district number thirty, or the new school district to be formed from said school district number thirty, and adjoining territory.
