hundred and sixty-nine; also certify to said county auditor the amount, by said board of supervisors levied, as provided in section two of this act, for the payment of the said amounts by them audited and allowed, as provided in section one. And the said county auditor shall extend upon the tax duplicate of said town in an appropriate column the aggregate amount so certified to him.

Duties of Town Tressurer.

SEC. 4. The town treasurer of said town of Leon is hereby authorized, and it shall be his duty to pay, out of any money in said town treasury not otherwise appropriated, any and all orders issued in pursuance of section one of this act.

When set to take SEC. 5. This act shall take effect and be in force from and after its passage.

CHAPTER LXXVIII.

March 5, 1865.

An Act to legalize certain orders issued by the council of the Town of St. Cloud, as a bonus to the St. Cloud Bridge Company, and to provide for the payment of the same.

SECTION 1. Legalization of bonds issued as a bonus to the St. Cloud Bridge Company.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the town orders to the amount of eight thousand dollars issued by the council of the town of St. Cloud as a bonus to the St. Cloud bridge company, payable to said company, pursuant to a resolution of said council passed on the nineteenth (19), day of August, A. D.

reighteen hundred and sixty-seven (1867), be and the same are hereby legalized and made valid and the same shall be

paid as hereinafter provided.

SEC. 2. There shall be levied and collected a special special tax tax for the year eighteen hundred and sixty-eight (1868), what purpose how collected and for three years successively thereafter, in each year, sufficient to pay and cancel one fourth of said orders and The said special tax shall be levied upon the taxable property of the incorporate town of St. Cloud, and, the said taxes shall be levied and collected in the same manner as other town taxes are now levied and collected. and the said orders and accrued interest thereon shall be receivable in payment of said special taxes.

The said orders and interest shall be paid out Orders and in-SEC. 3. of the moneys collected by said special taxes.

CHAPTER LXXIX.

An Act to authorize the city of St. Cloud to issue bonds.

March 6, 1868.

SECTION 1. City of Saint Cloud authorized to issue bonds-in what amount-at what rate of interest-for what purpose issued.

- 3. To be submitted to the legal voters of said city.
- When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

The city of Saint Cloud is hereby authorized to issue its bonds in the aggregate sum of not ex-City of St. Cloud coeding one hundred thousand dollars, and in sums not on what terms less than one thousand nor more than ten thousand dollars, pose. bearing interest not to exceed seven per cent per annum,
