CHAPTER XCII.

An Act to legalize and confirm the proceeding of certain special town meetings therein named, held in the town-ship of Houston, in the county of Houston.

- Section 1. Confirmation of the proceedings of special tax meetings held by the voters of said town.
 - The roturn of taxes authorized to be extended on the tax duplicate of 1867 are hereby made valid—duties of County Treasurer.
 - Not to interfere with provisions of the act authorizing the erection of certain bridge in said town.
 - 4. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Proceedings of special tax meetings confirmed. SECTION 1. That the action of the qualified voters of the township of Houston, in the county of Houston, at the special town meeting of said township, held on the twenty-ninth (29th) day of December, A. D. eighteen hundred and sixty-six (1866), and on the eighth (8th) day of June A. D. eighteen hundred and sixty-seven (1867), and the resolutions adopted thereat, authorizing the levying of certain special taxes for the purpose of building the temporary pontoon bridge across Root river in said township, are hereby legalized, confirmed and made valid.

SEC. 2. The return of taxes authorized by the voters of the said township at the special meetings mentioned in section one (1), by the town clerk of said township, to the county auditor of the aforesaid county of Houston, and by the said county auditor extended on the tax duplicate of eighteen hundred and sixty-seven (1867) of said county, against the real estate and personal property in said township of Houston, shall be in all respects and is hereby made legal and valid, and the county treasurer of said county shall have and possess all and singular the same powers and authority to collect the said taxes as are now possessed by him in collecting state, county and other taxes.

This act shall not be so construed as to inter- Not to interfere fere in any manner with the powers, rights and privileges granted and conferred to the the township, and the officers thereof under and by virtue of the provisions of chapter forty-five (45), of the special laws of eighteen hundred sixty-seven (1867), it being an act entitled "an act to anthorize the township of Houston, in the county of Houston, to build and construct certain bridges across Root river, and to provide means for building and keeping the same in repair."

Sec. 4. This act shall take effect and be in force from Whenactiotake and after its passage.

CHAPTER XCIII.

The supervisors of the town of New Au-To levy special burn, in the county of Sibley, are hereby authorized to take to the bridge. levy a special tax, to an amount not exceeding the sum of ten mills on each dollar of the valuation of the taxable property of said town, for the purpose of building a bridge across Buffalo Creek in said town.
