CHAPTER CXXII.

An Act to appropriate money to cover deficeencies therein stated, for the year eighteen hundred and sixty-seven.

March 3, 1863.

SECTION '. Appropriations for deficiencies.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the following sums of money or so much thereof as may be necessary, be and the same are hereby appropriated out of any moneys in the treasury belonging to the general revenue fund, not otherwise appropriated.

1st.—For deficiency of current expenses of the hospital Appropriations for deficiencies.

for the insane, six thousand dollars [\$6,000].

2d.—For deficiency of appropriation for the current expenses and salaries of officers of the state prison, three thousand two hundred and four dollars and fifty-nine cents **[\$3,204** 59].

3d.—For deficiency of appropriation for shop building for the state prison, two thousand three hundred and eighty-three dollars and seventy-five cents [\$2,383 75].

4th.—For stove and fixtures and repairs of capital, one hundred and twenty-six dollars and eighty cents [\$126-80].

5th.—For deficiency of appropriation for gas fixtures and lighting capitol with gas, one hundred and sevety-three dollars and twenty-five cents [\$173 25].

6th.—For moneys advanced by the state treasurer on the requisition of the governor, to aid certain citizens in the frontier counties of the state, saving and reserving all rights to reimbursements by said counties under the terms of such expenditures, six thousand nine hundred and forty-six dollars and forty-two cents [\$6,946 42].

7th—For expenses incurred by the state board of equali-

zation, one hundred dollars [\$100].

When act to take Sec. 2. This act shall take effect and be in force effect. from and after its passage.
