Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the following sums of money, or so much thereof as may be necessary, be, and the same are hereby appropriated out of any money in the treasury belonging to the general revenue fund not otherwise appropriated, viz:

First—For expenses of committee on charitable institutions in visiting hospital for the insane at St. Peter, ninety-eight dollars (\$98).

Second—For expenses of special committee visiting Winona normal school on investigation, ten dollars each. Total, forty dollars (\$40).

Third—To J. P. McIlrath for actual expenses incurred by witnesses in Van Solen case, three hundred and sixty dollars and forty cents (\$360 40).

Fourth—To Leonard Aldrich for money advanced for the relief of persons on the frontier during the summer of one thousand eight hundred and sixty-seven, two hundred and eighty-one dollars (\$281), the same to be paid on the surrender of the notes or obligations taken for such disbursements.

Fifth—For expenses of senate and house prison committees, in visiting state prison at Stillwater, one hundred and thirty-one dollars (\$131).

Sixth—To supply a deficiency in the appropriation for the *current expenses of the state reform school for the year one thousand eight hundred and sixty-eight*, seventeen hundred and eighty-six dollars and ninety-seven cents (\$1,786 97).

Seventh—To supply a deficiency in the appropriation of one thousand eight hundred and sixty-eight for fitting up rooms in the basement of the state capitol for the state library and Minnesota historical society, ten hundred and fifteen dollars and thirty-three cents (\$1,015 33).
