CHAPTER XCVI.

March 6,1869.

An Act relating to the conveyance of certain lands set apart for the construction of a State Road from Madelia, in Watenwan County, to the Western boundary of the State.

Sucremen 1. Duty of Governor upon completion of said road—specified time for the completion thereof—in case of failure lands to revert to the State.

9. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the governor of the state is hereby directed to withhold a conveyance to R. H. Bennett, J. B. Fish and S. R. Randolph, and each of them, their heirsand assigns, of the lands and every part thereof mentioned and referred to in chapter fifty-six of the special laws of one thousand eight hundred and sixty-two, and chapter one hundred and eleven of the special laws of one thousand eight hundred and sixty-six, until the county commissioners of the county of Watonwan shall certify to the governor that the said Bennett, Fish and Randolph, their heirs or assigns, have constructed a road from Madelia, in Watonwan county, to the western boundary of the state, as provided for in said chapter fifty-six of the special laws of one thousand eight hundred and sixty two. And it said road shall not be so completed by the first of November, one thousand eight hundred and sixty-nine, all of said lands shall absolutely revert to the state. Provided, however, That the county commissioners of said county may certify to the governor what proportion of said lands will, in their judgment, be a full and just compensation for all work done on said road by said parties, and thereupon, upon their application therefor, the governor shall convey the proportion of said lands so certified by said commissioners, to said Bennett, Fish and Randolph, their heirs and assigns, upon a receipt being executed to the state by said parties, and delivered to the governor,

CHAPTER XCVII.

An Act to appropriate money for the further construction of the State Road from Duluth to Vermillion Lake.

Feb'y 28, 1869.

SECTION 1. Appropriation for the further construction of said road-work to be executed under whose direction.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The sum of one thousand dollars, or so much thereof as may be necessary, is hereby appropriated out of any moneys in the state treasury not otherwise ap- Appropriation propriated, for completing the cutting out and construc- work done untion of the state road from Duluth to Vermillion Lake, in rection. Saint Louis county. The work to be executed under the direction of the county commissioners of Saint Louis county, upon whose certificate the bill for the work performed shall be audited by the state auditor and be paid by the state treasurer. Provided, That said appropriation shall not be paid till the auditor of St. Louis county shall have filed a notice with the state auditor, certifying that the stamp mills of the St. Paul Mining and Seymour Companies are delivered at Vermillion mines.
