

CHAPTER CVIII.

March 4, 1869:

An Act to provide for the location of a state road from a point on the St. Paul and Pacific Railroad in Meeker County, to the south line of McLeod County.

SECTION 1. Commissioners appointed to locate, survey and establish said road.

2. When and where to meet—vacancy, how filled.

3. Damages sustained, how ascertained.

4. How expenses of locating said road to be defrayed.

5. Commissioners to file plat of road.

6. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Orlando Graham, Lewis Harrington and W. H. Stocking, are hereby appointed commissioners to locate, survey and establish a state road from a point to be by them selected on the line of the St. Paul and Pacific Railroad in range twenty-nine (29) west, by way of Hutchinson to the south line of McLeod county.

SEC. 2. The commissioners or a majority of them, shall meet in the village of Hutchinson on the second Monday of April, one thousand eight hundred and sixty-nine, and proceed to locate and survey said road. *Provided*, That in the absence of any one of said commissioners, the other two shall have power to fill said vacancy.

SEC. 3. The said commissioners shall appraise the damages sustained by each owner of land through which the road shall pass, and in case any one shall feel aggrieved by said appraisal, he may within thirty days appeal in writing to the commissioners of the county in which said land is situated, and the said county commissioners shall determine the amount of damages as in the case of the location of a county road.

SEC. 4. All expenses incurred, and all damages assessed in locating and surveying said road under the provisions of this act, shall be paid by the counties through which said road shall pass respectively.

SEC. 5. Said commissioners shall cause an accurate plat of the survey and location of said road, together with their assessment of damages, to be filed in the office of the county auditor in each county in which it may run. To file plat of road.

SEC. 6. This act shall take effect from and after its passage. When act to take effect.

CHAPTER CIX.

An Act to vacate a State Road in Olmsted County.

Feb'y 16, 1869.

SECTION 1. State road vacated.

2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the portion of a state road running across the northwest quarter of the northwest quarter of section (8) eight, in township of Salem, and county of Olmsted, in the state of Minnesota, is hereby vacated. State road vacated.

SEC. 2. This act shall take effect from and after its passage. When act to take effect.
