Expenses, how to be deirayed. SECTION 1. Orlando Graham, Lewis Harrington and W. H. Stocking, are hereby appointed commissioners to locate, survey and establish a state road from a point to be by them selected on the line of the St. Paul and Pacific Railroad in range twenty-nine (29) west, by way of Hutchinson to the south line of McLeod county.

SEC. 2. The commissioners or a majority of them, shall meet in the village of Hutchinson on the second' Monday of April, one thousand eight hundred and sixtynine, and proceed to locate and survey said road. *Provided*, That in the absence of any one of said commissioners, the other two shall have power to fill said vacancy.

SEC. 3. The said commissioners shall appraise the damages sustained by each owner of land through which the road shall pass, and in case any one shall feel aggrieved by said appraisal, he may within thirty days appeal in writing to the commissioners of the county in which said land is situated, and the said county commissioners shall determine the amount of damages as in the case of the location of a county road.

SEC. 4. All expenses incurred, and all damages assessed in locating and surveying said road under the provisions of this act, shall be paid by the counties through which. said road shall pass respectively.
