CHAPTER XLVIII.

An Act to amend an act to authorize the Town of Chatfield Janua'y 10, 1869. to issue bonds to aid in the construction of a Railroad to Chatfield.

- SECTION 1. Amendment to Section one (1) of the act approved March, 5th, 1868. Authorized to issue bonds in the sum of one hundred and twenty-five thousand dollars to sid in the construction of a railroad to said town.
 - 2. Amendment to Section two (2) of said set. What denomination of bonds
 - 3. Amendment to Section three (3) of said act. Proposition to issue bonds to be submitted to legal voters at election.
 - 4. Amendment to Section five (5) of said act. Adjoining towns authorized to issue bonds-for what purpose -what amount of bonds may be issued.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That section one, of an act entitled "an act to authorize the town of Chatfield to issue bonds to aid in the construction of a railroad to Chatfield," approved February twenty-fourth, one thousand eight hundred and sixty-six, as amended by an act entitled "an act to amend an act to authorize the town of Chatfield to issue bonds to aid in the construction of a railroad to Chatfield," approved March five, one thousand eight hundred and sixty-eight, be and the same is hereby amended so as to read as follows:

(Section 1.) The town of Chatfield, county of Fillmore, Authorized to is hereby authorized to issue prior to January first, A. D. Issue bonds—in one thousand eight hundred and seventy five, bonds with what amount for what purinterest coupons attached, to an amount not exceeding in pose. the whole the sum of one hundred and twenty-five thousand dollars, to aid in the construction of a railroad to Chatfield aforesaid.

Sec. 2. That section two of said act, be and the same is hereby amended so as to read as follows:

Denomination of bonds to be issued.

(Sec. 2.) Said bonds shall be issued in sums of not less than one hundred dollars each, may bear interest at a rate not exceeding ten per cent. per annum, payable annually, and shall run for a period not exceeding twenty years from their respective dates. They shall be signed by the chairman of the board of supervisors, and countersigned by the town clerk of said town, and the principal and interest as they become due shall be payable to the person or corporation to whom they shall be issued or bearer.

The towns adjoining said town of Chatfield, Adjoining towns as well in Olmsted as in Fillmore county, and each of them, are hereby authorized at any annual or regularly called special meeting, or any adjournment thereof prior to said first day of January, one thousand eight hundred and seventy-five, to issue bonds to aid in the construction of said road, and provide for the levy of tax to pay the same, in the same manner, upon the same terms and conditions and with the same powers with respect to such issue of bonds as are hereinbefore provided in respect to the bonds which said town of Chatfield is herein. Provided, That the whole before authorized to issue. amount of bonds to be issued by any town or towns (including said town of Chatfield) shall not collectively exceed the sum of one hundred and twenty-five thousand dollara.

SEC. 5. This act shall take effect and be in force from when act to and after its passage.

CHAPTER LXIX.

An Act to extend to the Hastings and Dakota Railway Company, further time for the completion of a certain March 4, 1849. portion of their Railway.
