CHAPTER LXIII.

Janua'y 26, 1869.

An Act to authorize the Board of County Commissioners of Blue Earth County to issue bonds to bridge Blue Earth River.

- SECTION 1. County Commissioners authorized to issue bonds—in what amount—for what purpose.
 - 2. In what denominations—at what rate of interest—when made payable.
 - 8. By whom bonds to be executed—to be a valid debt against said county.
 - 4. An annual tax to be levied for the purpose of paying principal and interest.
 - 5. Duties of County Treasurer-penalty for violation of provisions of this act.
 - 6. Declared a public set-when to take effect.
 - 7. Repeal of former acts.

Be it enacted by the Legislature of the State of Minnesota:

To issue bonds emount-for what purpose.

SECTION 1. The board of county commissioners of the county of Blue Earth, are hereby authorized to issue bonds not exceeding twenty thousand dollars, to raise money to build a bridge across Blue Earth River, between the city of Mankato and the town of South Bend.

- The denominations of such bonds shall be determined by the board of commissioners; they shall be payable to order; they shall be signed by the chairman of the board, and attested by the county auditor; the seal of the county shall be attached thereto; they shall bear interest not exceeding twelve per cent. yearly, payable half yearly at Mankato in this state, and the principal thereof. shall be payable at any time not less than six nor more than twelve years.
- SEC. 3. It shall be the duty of the chairman of the board and the county auditor, to execute the bonds in the How bonds exe amounts and denominations, drawing such rates of interest, and payable as the board of commissioners shall direct, and the bonds when issued, shall be a valid debt against the county.
 - The board of commissioners are hereby au-

thorized and required, to levy a tax on the property of Annual texts to the county, to meet the interest and principal of such levied-for what

bonds, to be called The Blue Earth River Bridge Tax.

SEC. 5. When the county treasurer shall collect any Dutles of Counmoneys levied for such purpose, he shall not use any part ty Treasurer-thereof for any other purpose, and a violation of this lation of this act section shall be a misdemeanor.

This shall be a public act and shall be in force Declared a public act. Sec. 6. from its passage.

CHAPTER LXIV.

An Act providing for the rebuilding of a bridge across March 8, 1869. Crow River between the town of Dayton, in the county of Hennepin, and the town of Otsego, in the county of Wright.

- . SECTION 1. Commissioners appointed-for what purpose-when and where to meetlimitation of expense-Commissioners not to be interested in contract made in reference to said bridge-penalty for violation-if done according to terms of contract, Commissioners to accept the same.
 - 2. Costs and expense of building said bridge and per diem of Commissioners
 - 8. All bonds or orders paid on account of said bridge shall be upon the order of said Commissioners.
 - 4. Dutles of the County Commissioners upon proof furnished of the completion of said bridge.
 - 5. Duties of the Town Supervisors upon proof furnished of the completion of said bridge.
 - 6. Compensation of Bridge Commissioners.
