CHAPTER II.

An Act to amend Section Nineteen, Chapter Thirty six, General Statutes, relating to the duties of School District Clerks.

March 1, 1870.

SECTION 1. Amendment to Section Nineteen (19), Chapter Thirty-Bix (38), General Statutes. When Clerk to make report to County Superintendent—report to contain—

- 1. The names of all persons between the ages of five and twenty-one.
- 3. The number attending school.
- 8. Length of time school taught, and amount of wages paid.
- 4. The amount of apportionment fund received.
- The amount of money to be raised by tax—the purpose for which raised, etc.
- 2. When not to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Section nineteen, chapter thirty-six, of the general statutes, relating to the dutics of school district clerks, is hereby amended so as to read as follows:

Sec. 19. The clerk, on or before the fifth day of October of each year, shall make and transmit to the county superintendent, a report in writing showing:

First—The names of all persons, male and female, respectively, residing in the district, on the last day of September preceding the date of his report, between the ages of five and twenty-one years.

Second—The number of those who have attended the school during the year.

I hird-The length of time a school has been taught by

When clerk to make reportreport what to contain. a qualified teacher, and the amount of wages paid by the district.

Fourth—The amount of money received from the county treasurer from the money apportioned by the county auditor.

Fifth—The amount received from tax voted to be raised by the district; the purpose for which it was raised; the manner in which said sums have been expended; the condition of school house and grounds; the kind of books used, and such other facts as the state superintendent may require, which report shall be verified by his oath.

SEC. 2. This act shall take effect on its approval by When act to take the governor.

CHAPTER III.

An Act relating to School District Clerks.

March 4, 1870.

SECTION 1. Penalty for drawing an order on the District Treasurer directing the School Fand from its legitimate channel.

2. Penalty Imposed upon School District Clerk for nor-performance of duty.

3. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Any school district clerk who shall draw Penalty for drawan order upon the district treasurer directing the public in all school funds from their legitimate channel, shall be held personally responsible for twice the amount of such order.

SEC. 2. Any school district clerk who shall neglect to keep the books and records of his office in the manner penalty for negprescribed by law, or shall refuse to deliver up the books iet of dairy. and papers belonging to his office as clerk, to his successor in office, shall be liable to a fine of ten dollars for each offense.
