The clerk of the district court of the county of Dakota, first judicial district, is hereby authorized and required to procure suitable index books, and index in alphabetical order court records number one, and of record number one of marriage certificate and credentials of ordinations of ministers of the gospel; for which he shall be allowed ten cents for indexing each case or order entered on said court record, and ten cents for indexing each marriage certificate and ordination certificate.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The clerk of the district court in and for to procure books the county of Brown, is hereby authorized and required to procure as far as may be necessary such book or books as may be required to carry out the provisions of this act,

at the expense of said county, and to transcribe into such book or books all judgments and entries of the same to the extent that the same may be necessary, and all declarations of intentions to become citizens of the United States, and all final papers of citizens now on file in his office, but not of record, and index the same in alphabetical order.

The said clerk shall receive and be paid out Fees of clerk. Sec. 3. of the county treasury for the services hereinbefore required, fifteen cents for each folio actually copied by him.
