Be it enacted by the Legislature of the State of Minnesota:

Provisions of former act confirmed.

Change of name at incorporator.

That all and singular the provisions of SECTION 1. chapter one hundred and eighteen, of the special laws of one thousand eight hundred and sixty-eight, entitled "An act granting certain persons the right to manufacture and sell gas in the city of Rochester," approved March fifth, one thousand eight hundred and sixty-eight, be and the same are continued in full force and the same are confirmed to said corporation, it successors and assigns in all respects, except only in so far as the same is modified, amended or changed by the provisions of this act.

SEC. 2. That section one of said act be amended by substituting the name of A. K. Williams for the name of A. R. Williams, now appearing in the printed copy thereof.

SEC. 3. That section three of said act be amended so as to read as follows :

That said parties shall on or before the first when to meet for Sec. 3. day of October in the year one thousand eight hundred and organisation. seventy, meet in the city of Rochester, and organize themselves into a gas company, for the purpose of carrying out the intentions of this act, and shall adopt such rules and regulations as shall to them seem proper.
