

CHAPTER CXLII.

An Act to amend an act entitled an act for the location of a State Road from Lake George, in the County of Stearns, to Otter Tail Lake, or some point on Red River near said lake, in the county of Otter Tail. March 1, 1870.

- SECTION 1. Amendment to Section Three (3) of Chapter One Hundred and Ten (110) of the Special Laws of 1869. Expenses of constructing said road, how paid.
2. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That section three, of chapter one hundred and ten, of special laws of one thousand eight hundred and sixty-nine, be and the same is hereby amended by striking out the following: "Except that whatever expense shall be incurred in locating the said road in Otter Tail county shall be paid by Douglas county," then the balance of said section three, to read as follows: And the county auditors of the several counties through which or into which said road shall pass, are hereby authorized and required to issue the orders of their respective counties in payment of such accounts, including assessed damages, as the county commissioners of the said several counties shall find to be properly and justly due under the provisions of this act; which order shall be duly signed by the chairman of said board of commissioners in behalf of their respective counties. *Provided*, That for all expense incurred in laying out said road in Otter Tail county and paid by Douglas county prior to the passage of this amendment, the county commissioners of said Douglas county within one year thereafter, are hereby authorized to draw on the county treasury of said Otter Tail county to the full extent of all sums, with interest at ten per cent. from date of payment, so paid by the said Douglas county under and by virtue of the provisions of this act. *Provided also*, That the supervisors of any town through which or into

which said road passes, may at any time alter or change the location of the same within their respective towns.

When act to take effect.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER CXLIII.

An Act to locate and establish a State Road from the City of St. Paul, in the County of Ramsey, to the City of St. Anthony, in the County of Hennepin.

March 7, 1870.

- SECTION 1. Commissioners appointed to locate, survey and establish said road.
2. When and where to meet.
 3. Commissioners to file plat of road.
 4. Damages sustained, how ascertained.
 5. How expenses of locating said road to be defrayed.
 6. County Commissioners of Hennepin county authorized to appropriate money—
for what purpose—in what amount.
 7. When act to take effect.

Be it enacted by the Legislature of the State of Minnesota:

Commissioners appointed to locate state road.

SECTION 1. That J. W. Bass, of the county of Ramsey, and David Edwards and Winthrop Young, of the county of Hennepin, be and are hereby appointed commissioners to locate, survey and establish a state road from the city of St. Paul, in the county of Ramsey, via Lake Como to Bay Street, in the city of St. Anthony, in the county of Hennepin.

When and where to meet.

SEC. 2. The said commissioners or a majority of them, shall meet at such place as may be most convenient, on any day subsequent to the passage of this act, and before the first day of January next, and proceed to the discharge of the duties imposed upon them by this act, and in the discharge of said duties may employ a competent surveyor and such chainmen and axmen as may be necessary.
